Peddocks Island's popular **yurt campground** was sold out every weekend

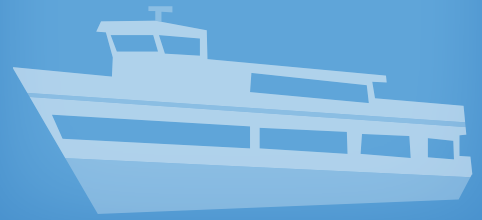


400 Boys & Girls Club and YMCA campers spent a full week learning about the park through Harbor Discovery Camps

300 veterans and their family members visited Georges Island during our annual **Veterans Day Cruise**



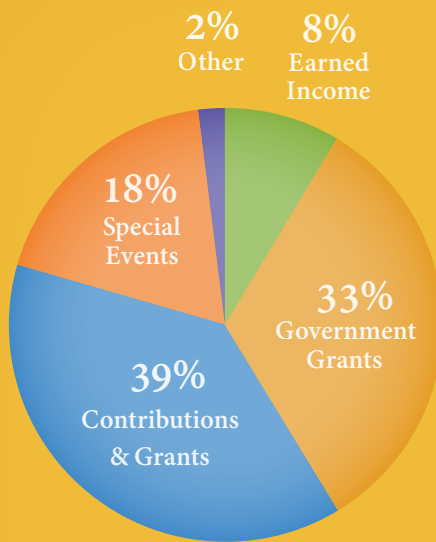
Members of the community contributed **30,000** volunteer hours to help with programs, events, park clean-ups and improvement projects

Boston Light re-opened following a **full restoration** in time for its **300th birthday**

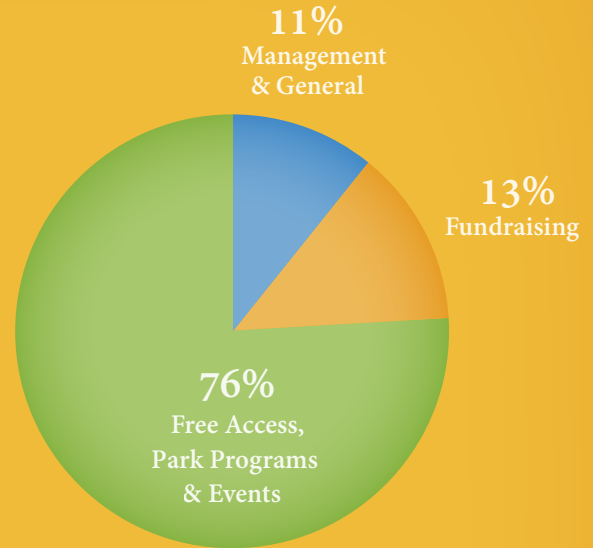
