This is an exciting opportunity to join a diverse team of talented individuals who work closely with public agencies, communities, and private & nonprofit partners. As a member of the Stone Living Lab Education and Engagement team, the Summer Climate Education and Program Intern will assist with public programs and education projects in and around Boston Harbor, including the Boston Harbor Islands National & State Park.

## **Organization Overview**

The Stone Living Lab is an innovative and collaborative initiative for testing and scaling up nature-based approaches to climate adaptation, coastal resilience and ecological restoration in the high-energy environment of the Boston Harbor Islands National and State Park. A "Living Lab" brings research out of the lab and into the real world by creating a user-centered, open, innovative ecosystem that engages scientists and the community in collaborative design and exploration. The Stone Living Lab is a partnership of the Boston Harbor Now, UMass Boston School for the Environment, the City of Boston, the National Parks of Boston, the Massachusetts Department of Conservation and Recreation, the Executive Office of Energy and Environmental Affairs, and the James M. and Cathleen D. Stone Foundation that engages scientists and the community in research, education, and the promotion of equity.

The Intern will be employed through Boston Harbor Now, the non-profit partner of Stone Living Lab. Boston Harbor Now envisions a vibrant, welcoming, and resilient Boston Harbor, Waterfront, and Islands for the benefit of everyone. Our mission is to ensure that these unique regional resources are accessible, inclusive, and properly adapted to the risks of climate change.



BHN focuses on **Coastal Resilience**, **Access**, and **Equity**. BHN works with public and private partners to increase people's awareness of and access to parks and public spaces on Boston Harbor through programming, communications, and engagement. The organization serves as the

legislated non-profit partner of the <u>Boston Harbor Islands National and State Park</u> and the city's partner for the Boston Harborwalk and Moakley Park.

Current priority projects include the <u>Stone Living Lab</u>, focused on finding nature-based solutions to sea-level rise, and <u>Harborwalk 2.0</u>, a framework for improving waterfront development on Boston Harbor as well as imagining a bolder vision for the waterfront and islands. Harborwalk 2.0 goes beyond existing regulations in anticipation of building a more equitably and accessible waterfront that is prepared for the coastal impacts of climate change. Finally, BHN is focused on improving <u>Community Engagement</u> at Moakley Park and projects around Boston Harbor to create a more welcoming and inclusive Harbor.

#### **About the Position**

This summer, the Stone Living Lab seeks a motivated and enthusiastic intern to assist with public programming and education projects in and around Boston Harbor, including tabling events, community cruises, and youth programs! Reporting to the Lab's Senior Manager for Education and Engagement, this intern will help facilitate a series of enriching public programs on a weekly basis. Many duties take place largely outdoors within the Park and around the mainland waterfront.

This position requires a flexible work schedule, including some evenings and weekend work.

## Responsibilities

- Working outdoors in and around Boston Harbor with a diverse audience of families and community groups, conducting work with professionalism and compassion for everyone encountered, in close collaboration withWith both the Senior Manager and Program Coordinator for Education and Engagement,
- Leading family-friendly activities like science experiments or arts and crafts
- Working with the communication team to promote program offerings through online calendars and social media
- Representing the Stone Living Lab professionally in interactions with vendors, partner staff, and the public
- Other duties in the office and in the field as needed such as:
  - Supporting programs with a focus on data collection and analysis
  - Supporting partners and providing customer service by connecting via email and phone
  - Researching new program ideas and vendors for 2025

 Managing partner schedules and layouts, and assisting in administrative duties as needed

## **Qualifications and Experience**

We recognize that experience can be gained in various ways: lived, professional, volunteer, and more. We encourage you to apply and to consider what you can contribute to youth engagement programs. Black, Indigenous, people of color, people with disabilities, and people with non-dominant gender identities who may not believe they meet all the described qualifications are encouraged to consider what they can contribute to the Stone Living Lab and apply. We are looking for candidates who possess:

- Comfort and experience in facilitating public programming for all ages
- Problem solving skills and ability to present possible solutions to supervisor
- High school diploma or GED is preferred but not required. Other credentials, traditional and nontraditional, and experience considered and appreciated.

#### An ideal candidate:

- Has a strong work ethic, is good at taking direction, and is able to work with minimal supervision
- Has experience and/or interest in climate resilience, environmental science, event planning, creative placemaking, community activation, and/or the nonprofit sector a plus.
- Has a demonstrated interest in public parks and/or community programming and events
- Has experience working with families and the public, particularly in an event setting
- Is comfortable leading activities outside in a range of weather conditions
- Is willing to work outdoors in a range of weather conditions
- Is proficient or fluent in a second language
- Is a proactive problem solver
- Pays attention to detail
- Works well with a variety of stakeholders and partners
- Believes in the mission of the Stone Living Lab

#### **Hours**

Full-time intern positions from June through August (13 weeks). The work schedule is typically Tuesday through Saturday (some Sundays) and will include 1 to 2 evening shifts (1pm – 9pm) a week.

## **Benefits and Salary**

Hourly, non-exempt employee; \$18.00/hour working an average of 35 hours/week for 13 weeks (\$8,100 for 450 hours). Sick time and paid holidays (e.g. Fourth of July) included.
